2020年是歷史性的一年。自年初開始，新冠肺炎席捲全球，對經濟、社會民生造成史無前例的影響。香港是一個外向型經濟體，在疫情衝擊下，無可避免受到極嚴重的影響。社會企業的經濟規模不大，在持續的疫情下，經營相當困難。

為了解疫情對社企的影響，本會在今年三月及九月進行調查，並將數據及分析透過新聞發布會向外公布，亦向有關部門倡議，將獲本會發出認證的社企納入政府的各項防疫抗疫支援措施；亦致函各政府及相關機構，例如醫管局、社會福利署等等，為社企爭取租金減免及為受雇於社企的殘疾人士提供薪金補貼等等。有關的倡議均獲得正面回應，而獲本會認證的社企亦進一步被政府及有關組織確認為識別社會企業的一項參考標準。為應付會員防疫所需，本會亦積極聯繫公司團體，送出防疫物資，當中包括星展銀行、復康力量及金鈴化工有限公司等。

由於疫情影響，本會今年所有活動均移師網上進行，分別舉行過兩次SE-Chatroom，讓不同行業及培訓服務的社企探討如何互相支援，以面對疫情下的挑戰。此外，亦舉辦五次的SE-Start-up，邀請本會理事及行業專家，就申請政府的社企起動基金「創業展才能」、「伙伴倡自強」、成立社企的法規、保險知識及運用義工等安排視像工作坊，反應理想。

本會亦繼續參與社企世界論壇，除推薦會員出席論壇工作坊外，亦資助會員社企出席歷來首次在網上進行的社企世界論壇。本會乃社企民間高峰會組織委員會成員，今年策劃及推動高峰會一個名為「再思30」的觀塘地區活動。參加者自我挑戰，思考在新常態下，個人與社區及環境的關係，重塑個人的生活取向。

社企認證是本會的品牌項目。到目前為止，累計有217個社企項目獲得認證，而本會亦樂見一些年輕人創辦的Start-up，及非NGO背景的社企陸續加入認證，成為加入社企界的一個台階。社企認證計劃發展至今已有六年，本會正重新檢視認證的內容準則，亦計劃將認證數據電子化，讓初次申請認證，及到期續證的手續，更便捷有效。

會長的話 CHAIRMAN'S MESSAGE

今年的社企員工嘉許禮透過網上直播平台進行，本會邀得民政事務局徐英偉局長作為主禮嘉賓，亦獲得煤氣公司、Recruit，新生會及馬錦華培訓公司作為支持機構，雖然未能實體進行，會員亦積極推薦員工參與，有108位長期服務及優秀員工獲獎。員工嘉許禮是本會每年所舉辦的一個重要業界聚會，希望明年疫情過後，實體的嘉許禮能恢復舉行。

疫情下，本會仍不斷拓展網絡，與持份者推動香港社企業界生態的健康發展。過去一年，本會積極探訪會員社企，參與英國文化協會所舉辦的社企調查、與新任民政事務局長安排會面、接受不同媒體訪問、支持界內活動，例如十一良心消費運動、香港社企挑戰賽，並與商界組織拓展關係，推動私營企業CSR與社會企業協作，促進彼此的改進與發展。

展望未來，本會計劃加強為社企員工提供各類培訓、為有需要的社企進行一對一的深入教練服務，亦會向政府申請津助員工名額，在社企開設新崗位，讓有志人士對社企有所認識。此外，亦會進一步支援社企初創，引入更多社會資源，促成政府、商界、及社企的三方協作，為香港社企業界的蓬勃發展擔當促進者的角色。

2020 is historic. The Covid-19 has been spreading all over the world since the year's beginning, which has severely impacted global economy and all walks of life. Being an open economy, Hong Kong is no exception. Under the pandemic, Hong Kong's social enterprises, (SEs) have been facing many challenges.

GCSE has conducted 2 surveys this year in March and September respectively to explore how SEs were affected. Apart from announcing study results through media, we also advocated for SEE Mark certified SEs to be included in the Government's anti-epidemic relief programmes. Hospital Authority agrees to offer rental concession while Social Welfare Department's 3E Fund provides subsidy to partially cover salaries of SEs' disabled employees.

With our tremendous effort in promotion, now certification by our SEE Mark has become a key indicator to identify a bona fide SE. And to meet pressing need of SEs in facing the epidemic, GCSE appealed for donations and was offered face masks and antiseptic materials from DBS, Hong Kong Rehabilitation Power and Amiralty Chemical Limited for distribution to our needy member SEs.

All events of our Chamber went online this year due to the epidemic. 2 rounds of SE-Chatroom with SEs from all trades and SEs from training sector were conducted for SEs to explore possibility of collaboration among themselves so as to survive this plague. Besides, 5 sessions of SE Startups were staged online to introduce Dos & Don'ts in applying for Government seed money from 3E Fund and Enhancing Self-Reliance Through District Partnership Programme, to introduce legal procedures in setting up SEs, insurance matters and utilization of volunteers. And the general feedback was positive.

GCSE continued to take part in the Social Enterprise World Forum (SEWF) this year. Besides recommending SE members to share in the workshop, our Chamber also provided subsidies to SEs to register for this year's unprecedented online forum. GCSE has been one of the members of the Organizing Committee of the SE Summit (SES) . We launched a programme namely JOYS30 being the Kwun Tong District programme of this year's SES. JOYS30 is a self-challenge event aims to inspire participants to re-think their relationship with their community and the general ecosystem to review their life goals under the new normal.

SEE Mark has all along been a signature scheme of GCSE. Up till presently, 217 SEs have acquired SEE Mark. Our Chamber is delighted to see that more start-ups initiated by youngsters, and SEs without NGO background are applying to be certified and becoming a member of the SE sector. SEE Mark has been in operation for about 6 years, GCSE is now reviewing the criteria and assessment contents of the scheme. We also plan to digitized data collection to enhance application and renewal of the SEE Mark Scheme.

會長的話 CHAIRMAN'S MESSAGE

We have invited Mr. Caspar Tsui, Secretary of HAB to officiate this year's Award Ceremony of Outstanding SE Employee being held online on Youtube. The ceremony was sponsored by Towngas; Recruit, New Life and Ma Kam Wah & Co. 108 Employees were presented long service and outstanding awards this year. The Award Ceremony is an annual key event in the SE sector. We wish it be resumed to back to face-to-face next year.

Despite the pandemic, our Chamber continues to expand its network with stakeholders to help promoting a robust SE ecology in Hong Kong. We visited SE members, recommended our member SEs to apply for loans, support the SE study conducted by British Council, to meet the new Secretary of HAB, attend media interviews, join sector events such as Ethical Consumption Month, HKSE Challenge, as well as network CSR of commercial firms to create win-win synergy.

In the coming years, GCSE will strengthen capacity building of SE operators by conducting more training workshops and coaching services. We are also applying for funds to create new positions in SEs for persons who are interested in SE. We will enhance our support to new start-ups, to leverage more resources to facilitate and create synergy among Government, businesses and SEs to do good for our Hong Kong Society.

新聞發布會 Press Conferences

本會分別在本年3月及9月就新冠肺炎疫情對社企的營商影響舉辦新聞發布會，大部分受訪社企生意額大幅下跌，對全年銷售預期感到悲觀。

本會向政府提出多項建議，希望政府在疫情下協助社企度過難關，包括提供資金援助予以下合資格社企：

1. 獲得本會社企認證（SEE Mark）的社企；
2. 刊登於香港社會服務聯會編製的《社企指南》的社企；
3. 受惠於政府資助，如社會創新及創業發展基金、「夥伴倡自強」社區協作計劃和「創業展才能」計劃

以上建議喜獲政府接納，成為「防疫抗疫基金」下社企援助措施的涵蓋資格。

In March and September of this year, HKGCSE held press conferences on the impact of COVID-19 on the business of social enterprises. Most of the responded social enterprises found a sharp decline in their revenue and were pessimistic about their annual sales expectations.

HKGCSE put forward a number of suggestions to the government to ask for assistance to social enterprises to tide over the difficulties during the epidemic, including providing financial assistance to the following eligible social enterprises:

1. Certified by SEE Mark by HKGCSE;
2. Listed in SE Directory compiled by the Hong Kong Council of Social Service;
3. Benefited from government funding, such as SIE Fund, Enhancing Self-Reliance Through District Partnership Programme and “Enhancing Employment of People with Disabilities through Small Enterprise” Project.

The above suggestions were accepted by the government and became the criteria for the social enterprise assistance measures under the "Anti-epidemic Fund".

In order to benefit more social enterprises, in addition to the distribution of materials to our social enterprises member, non-member social enterprises were also benefited.

「社企認證」 Social Enterprise Endorsement Mark (SEE Mark)

「社企認證」是香港首個為社企而設的認證制度，是一套專業、客觀、全面性的評審系統。這系統旨在幫助社企認清不足之處，針對性地改善其營運能力，同時增加社企營運的透明度，加深大眾及潛在投資者對社企的認識和支持。截至2020年10月，累計217個社企項目已獲認證。

SEE Mark is the first accreditation system for social enterprises in Hong Kong, which is a professional, objective and comprehensive assessment system. It aims to uplift the social enterprises and improve the level of public confidence. Until October 2020, there are totally 217 cumulative accredited social enterprises.

Hong Kong Social Enterprise Employee Recognition Scheme 2020

計劃旨在表揚社企員工的優秀表現及肯定他們的貢獻，嘉許禮於2020年11月18日移師至網上舉行。活動有幸邀請到民政事務局局長徐英偉,JP擔任主禮嘉賓，並喜獲香港中華煤氣有限公司、馬錦華專業管理培訓公司、新生精神康復會贊助，以及媒體夥伴Recruit的支持。

本年共有108位員工獲得嘉許，另有28位榮獲優秀長期員工服務獎，每位獲選之員工可獲港幣\$1,000作嘉許。

The Scheme aimed at recognizing the outstanding performance of social enterprise employees and affirming their contribution. The ceremony was held online on 18th Nov 2020. We were glad to have Mr Caspar Tsui Ying-wai, JP, Secretary for Home Affairs Bureau, as the officiating guest. It was also our honor to receive sponsorship from The Hong Kong and China Gas Company (Towngas), Ma Kam Wah & Co, New Life Psychiatric Rehabilitation Association, as well as support from Recruit as our media partner.

A total of 108 staff were commended this year. Another 28 staff were awarded Long Service Award and each awardee was awarded HK\$1,000.

政策倡議 Policy Advocacy

本會積極回應政府的施政及政策，以及參與政策小組會議，並就政府的施政報告、財政預算及其他政策提出書面建議。本會在7月面見民政事務局局長徐英偉，JP，向局長反映社企的困難，以及探討如何支援業界的發展。因應疫情的影響，本會亦就社企營運狀況多次進行問卷調查，收集意見後向政府及醫院管理局提出建議，喜獲政府為社企提供援助措施，醫院管理局亦向社企租戶提供租金寬減措施。

HKGCSE proactively advocated social enterprise related issues in response to government policy. We also submitted written proposals on the government's policy address, budget and other policies. In July, we met with the Secretary for Home Affairs Bureau, Caspar Tsui Ying-wai, JP, to reflect the difficulties of social enterprises and discuss how to support the development of the industry. In response to the epidemic, HKGCSE conducted a few surveys on the operation status of social enterprises. After the collection of feedback, the suggestions were sent to the Government and Hospital Authority. The government provided assistance measures for social enterprises and Hospital Authority also provided rent reduction measures to social enterprise tenants.



教育及推廣 Education & Promotion

教育是傳承社會企業理念的重要工作，以培育新一代投身社企、共建美好社會。過去一年，本會積極透過不同渠道宣揚社企工作，例如：籌辦暑期實習生計劃、招募公眾人士成為本會社企Buddies和社企大使，讓公眾更了解社企的意義。

Education is an important tool to spread the concept of social enterprise and bring long-term social change. It paves the way for youngsters to devote themselves into the industry and contribute to the community. HKGCSE promoted social enterprises and nurtured social entrepreneurs through different channels such as summer internship and the recruitment of SE Buddies and SE Ambassadors.

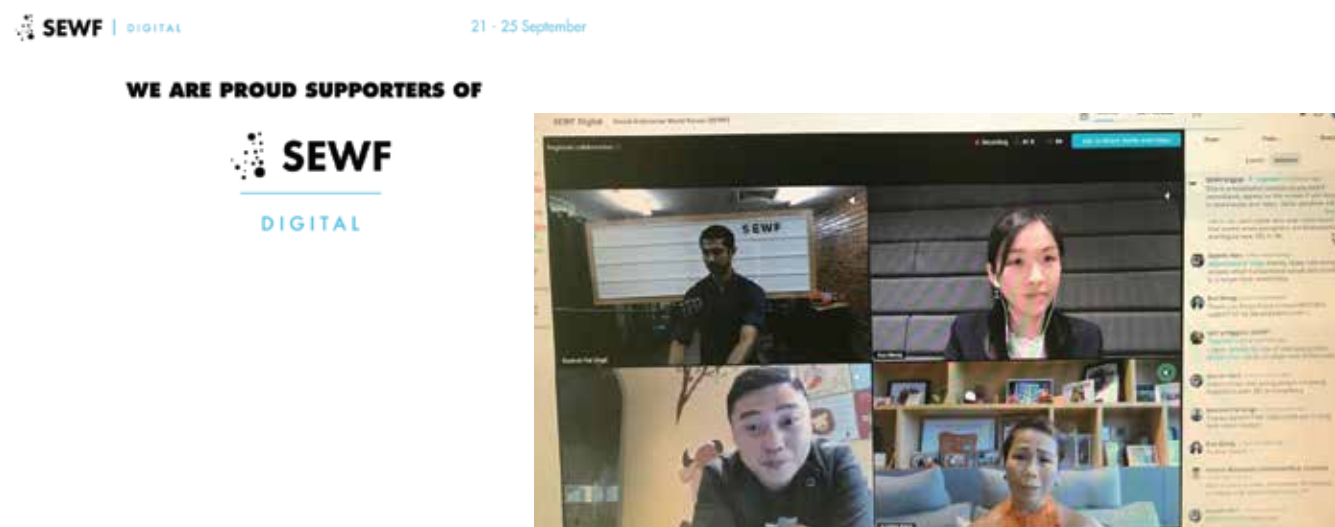

會員架構 Membership Structure

本會新增了兩類會籍，共分為四個類別，詳細資料如下：

1. 機構會員 (基本會員)
2. 機構會員 (附屬會員)
3. 社企Buddies — 對社企有興趣的非在學人士，包括在職人士及退休人士或本會機構會員的社企項目職員。
4. 社企大使 — 大專程度或以上對社企有興趣的全日制或兼讀制學生（社企大使於畢業後可申請成為社企Buddies）。

Two categories are newly added. We currently have four categories of membership:

1. Institutional Member (Full Membership)
2. Institutional Member (Associate Membership)
3. SE Buddies Non-students who are interested in social enterprises, including working groups and retirees or Social enterprise staff of institutional members.
4. SE Ambassador College degree or above, full-time and part-time students who are interested in social enterprises (After Social Enterprise Ambassadors complete their studies, they can apply to become Social Enterprise Buddies.)

會員服務 Member services

本會為會員定期提供一對一的「個別社企諮詢服務」。這計劃針對特定的社企行業，由該界別的資深營運者直接解答會員的問題或提出建議。本會亦定期出版會員通訊，提供社企業界最新活動的資料，其他會員服務包括：租用場地及廣告燈箱、通訊地址及收信服務、影印及傳真服務。

HKGCSE regularly provide one-on-one social enterprise consulting services for members. Senior operators in the sectors answer members' questions or provide suggestions to specific social enterprises. We also published newsletters on a regular basis to provide the latest information of the industry. Other member services include renting venues and advertising boxes, mailing address and receiving services, photocopying and fax services.

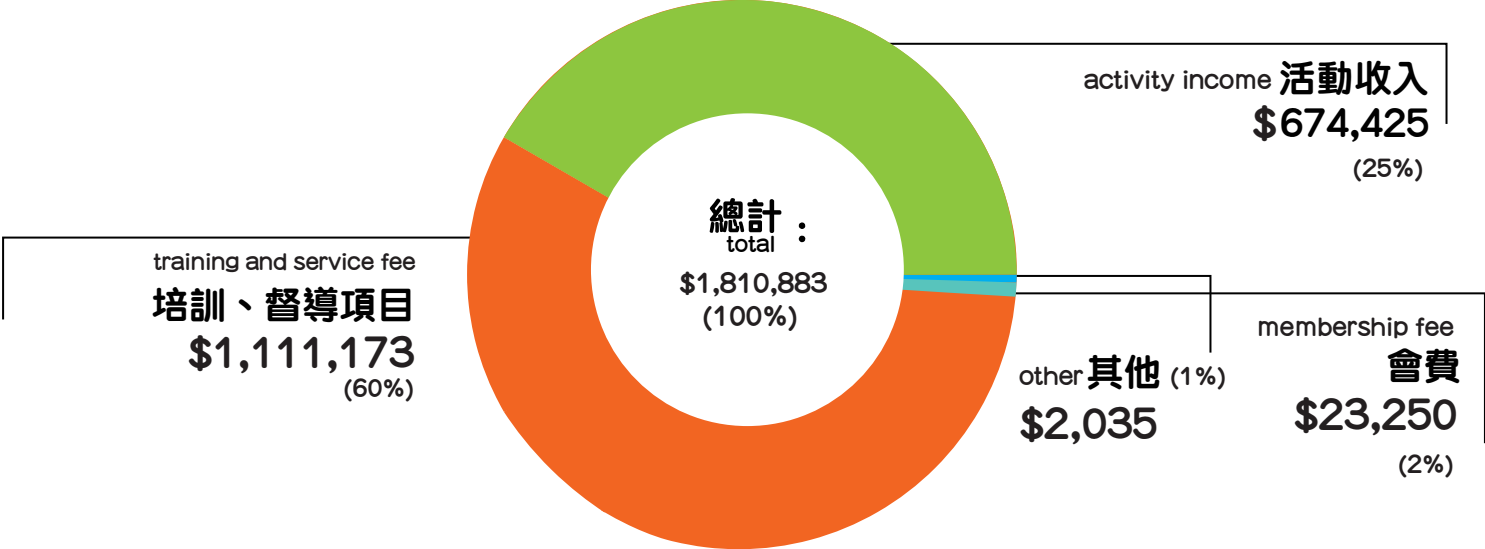

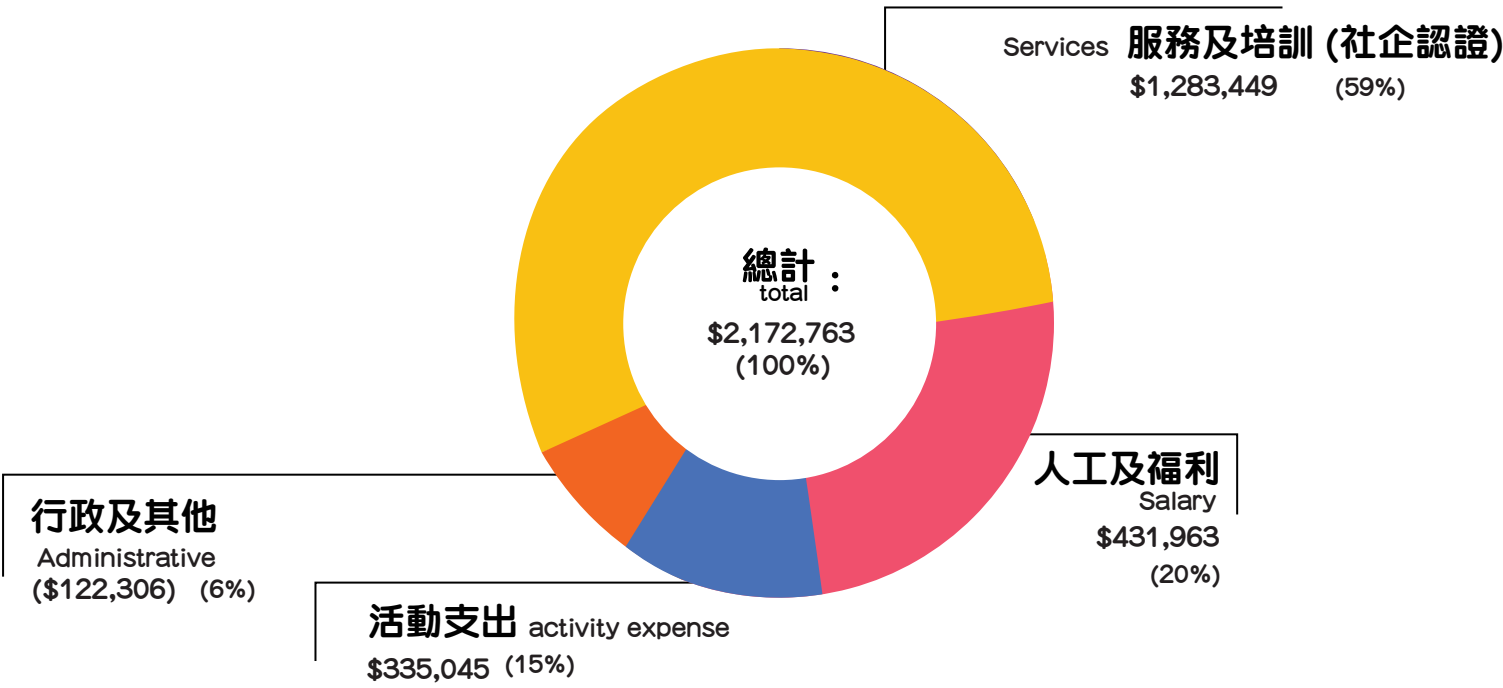
